crisis occurs, the Senior Care Resources Group can help.

The group of area professionals focuses on helping the senior population and offers solutions, such as living options, health insurance programs, area medical services, opportunities at the senior center and information on probate needs.

For example, an elder law attorney will help you develop a blueprint or "planning strategy" and make sure you have the right tools in place for carrying out the plan or choosing someone else to carry it out for you.

The group's members will explain housing options available for those aged over 55 and help you understand the differences among active 55 communities, congregate housing, subsidized senior housing, assisted living

communities and skilled nursing facilities.

The group will also provide answers on Medicare, supplemental insurance, long-term care insurance, Medicaid/Title 19 benefits and the Connecticut Home Care programs.

Participants in the group include an expert on VA benefits for people at home and in assisted living facilities and another expert on reverse mortgages.

Professionals with information regarding dementias, meeting home-care needs, and hospital and hospice services are involved in the group as well.

Outside of Scouting, Liguori has also played an active role with the Village Fair Days Committee since he joined it in 2003.

His primary duties have been trash collection and clean-up, and helping the fair's youth volunteers.

Outside of town, he has spoken to the freshman class at Empire Beauty School in New York City, sharing his personal story.

In addition, he is known for quietly providing help to those in need around New Milford.

Over the years, Liguori has worked at various companies. In his early years in town, he worked

as a "grease monkey" at Jiffy Lube, a position that helped land him a job running his own store while he lived in Indiana from 1993 to 1995.

Upon his return to Connecticut in 1995, after suffering a tragic motor vehicle accident that claimed the life of his fiancée, he assumed a job on the manufacturing floor of Wentworth Laboratories in Brookfield.

Liguori's interest and involvement in a particular engineering project for IBM eventually moved him to the engineering department, where he worked as an engineer technician.

In 2003, after losing his job at Memry Corp., he followed the sugges-

tion of a friend, who at one point had recommended he look into hair-dressing, and he became a hair stylist.

Today, Liguori is part of a landscaping crew and is a hair stylist.

Liguori and his family were sponsored by his aunt to come to the U.S. from San Paulo when he was almost 17.

Upon arrival, he had to re-educate himself, which included learning English.

"I didn't say 'hello,' let alone know how to spell it," Liguori said of the language barrier.

Liguori and his wife, Kristin, were married in 2000 and have two children, Dominic, 17, and Luka, 11.
